Divided into sections on issues of control and confusion, security and risk, distance and closeness, and sex and sensitivity, the book looks at how to negotiate complex grey areas and raises important questions that researchers need to consider before, during and after their time on the ground.

Governments have developed a convenient habit of blaming social problems on their citizens, placing too much emphasis on personal responsibility or 'nudging' people to better behaviour.

Dowding argues for a radical shift and shows that responsibility for many social crises, including obesity, gun crime, homelessness, drug addiction and problem gambling, should be placed at the feet of politicians. Encouraging us to stop scapegoating fellow citizens, he shows how we can demand more from our governments, who have the real power and responsibility to alleviate problems and bring about change.

The New Technocracy

Anders Esmark, University of Copenhagen

It took the dramatic rise of populist parties and movements across the Western hemisphere to generate academic interest in the fact that democratic politics have for a long time been co-opted and challenged by an altogether different regime: that of technocracy.

This book provides the first comprehensive analysis of the current technocratic regime which the author argues emerged in the 1980s as a new 'post-industrial' form of technocracy. Populism, Esmark argues, is a sign that the technocratic bluff has finally been called and that technocracy posing as democracy will only serve to exasperate existing problems. This book sets a new benchmark for studies of technocracy, showing that a solution to the challenge of populism will depend as much on a technocratic retreat as democratic innovation.
