# What Are Museums For?

Jon Sleigh

- Cleverly structured like a virtual museum tour, using seven museum objects in seven different museums, each of which addresses a different aspect of the title
- The author has conducted a series of interviews specifically for this project to bring in a plurality of voices from leading curators, sector specialists, museum staff and members of the public
- Will bridge the gap between the curatorial knowledge of institutions and social value in the wider community

Catherine Oliver

**Catherine Oliver** is a lecturer in the Sociology of Climate Change at Lancaster University. A geographer interested in research beyond the human, she works on historical and contemporary veganism, the ethics and politics of interspecies friendship through human-chicken relationships, and multispecies ethnographic research, most recently with seabirds. She has been featured on BBC Radio 3's Free Thinking, written for Tribune, and had her work cited in The Guardian and The Independent. She is the author of Veganism, Archives, and Animals: Geographies of a Multispecies World (Routledge, 2022) which won the Runners' Up Prize in the Social and Cultural Geography Research Group of the Royal Geographical Society's Book Prize in 2022 and was a finalist for the prestigious AHRC/BBC's New Generation Thinkers.

'Athletes first' is a slogan the International Olympic Committee often touts, but the reality is very different, as preeminent Olympics expert Jules Boykoff shows in this book. While the world's attention is riveted by the triumphs and tribulations on their screens, there is much that goes on behind the scenes that is deeply troubling: athletes are increasingly voicing concerns over physical, mental and sexual abuse, and they are collectively expressing grievances around equity and human rights.

Outside the stadiums, problems range from the democratic deficit and corruption surrounding the awarding of the Games, to displacement of people and gentrification of neighbourhoods to make way for Olympic venues, to the environmental damage that Olympic construction inflicts and then tries to greenwash away.

Boykoff tells us that radical steps are required if the Games are to be fixed and only then will they be truly 'athletes first'.



# What Is History For?

#### Robert Gildea

- Many historians mellow with age: Robert Gildea, who won the Wolfson Prize for History in 2003, has got angrier about multiple forms of injustice, and this book channels that anger constructively into exploring how both ancient and modern history can be a force for good
- Advocates a kind of 'citizen history', akin to citizen journalism as a complement to professional historians
- Up-to-date in its engagement with current issues, but also deeply informed by Gildea's knowledge of history and the uses to which it has been put

**Robert Gildea** is Professor Emeritus of Modern History at the University of Oxford, and a specialist on French and European history in the 19th and 20th centuries. In 2003 he won the Wolfson Prize for History.

"History", suggests Robert Gildea, "is a battlefield." Questions of power, rights, identity and nationhood always have an ancient and modern historical dimension and countries still go to war over their interpretation of history. Yet accounts of history are just as prone to fabrication as fake news, so how can we tell good history from bad? How can history be critical, learning from the past and righting wrongs, rather than divisive, such as riding roughshod over the rights of others?

In this passionately argued book, Gildea suggests that the more people who really understand what good history entails, the more likely history is to triumph over myth. He sees positive signs in public history, citizen historians and community projects, among other developments. And he debunks claims that 'you cannot rewrite history', arguing that good history that's attuned to its times must be rewritten time and again.



# What Are Prisons For?

Hindpal Singh Bhui

- Prisons are an unknown world to most readers – this book demystifies and illuminates the debate
- The author has 20 years' experience of working in prisons
- The book's unique perspective blends the personal, professional and theoretical to address big questions around the purpose of incarceration

**Dr Hindpal Singh Bhui** OBE is an Inspection Team Leader at HM Inspectorate of Prisons and a Visiting Law Professor at the Centre for Criminology, University of Oxford. He has worked in prisons for over 20 years undertaking hundreds of visits to places of detention around the world. He has also led various thematic reviews on custody in England and Wales, including on foreign prisoners, minority ethnic prisoners, rehabilitative work and immigration detention. He has given evidence to numerous UK parliamentary committees, public inquiries and the European Parliament, and is a regular speaker at international conferences.

What does a good prison look like? Over eleven million people are currently locked up in prisons across the world, but does that mean that prison actually works? The answer usually depends on what people believe and feel about crime, punishment and what happens inside prisons. The deep social and personal impact of prisons demands that we try to search for a better understanding of the evidence and ideas that have made prisons so ubiquitous.

Hindpal Singh Bhui, with 20 years' experience of visiting and working in prisons worldwide, argues that we need to look at who is sent there and why, to disentangle reality from ideology and myth. Introducing the competing histories of prisons and allowing the voices of prisoners, prison staff and victims to be heard, he asks whether there is a better way to achieve what society wants from its prisons.



# What Are Animal Rights For?

Steve Cooke

- Combines consideration of the philosophical grounding and the realworld application of animal rights
- Written from an unambiguously proanimal rights stance, but one that invites the reader to imagine what a world in which animals enjoyed rights would be like, rather than preaching
- Covers long-standing issues such as vivisection and factory farming, but also up-to-date debates such as political representation of non-humans and wild animal suffering that have gained prominence

Previously, he held positions on animal rights theory and environmental politics at the University of Sheffield and Keele University and was the Society for Applied Philosophy's 30th Anniversary Postdoctoral Fellow for a project on animal rights and environmental terrorism.

It seems clear that many formerly stable societies in wealthy developed countries appear to be falling into an apparent state of 'permacrises', accompanied by an increasingly angry and irrational social and political culture that is undermining the peace and stability of our societies and democratic institutions, from the local to the global.

Applying an original biosocial approach (the social map), and drawing on ideas and evidence from sociology, history and political economy to psychology, neuroscience and epigenetics, John Bone argues that conditions in our turbo-capitalist and increasingly estranged, media dominated societies have created a toxic environment, deeply damaging to our mental and physical health. As well as shedding new light on our current troubles, Bone also outlines why this leaves us ill prepared to deal with two of the greatest challenges confronting humanity: the rise of Al and automation and how we deal with climate change.



In August 2021, the US-led coalition withdrew from Afghanistan. The Taliban quickly returned to power, leaving many wondering what 20 years' worth of statebuilding efforts, and considerable loss of life and treasure, had been for. The EU had been a key actor in statebuilding activities, and in 2022 the author was asked by the European Parliament's Foreign Affairs Committee to undertake the first external evaluation of the EU's efforts in Afghanistan.

This book publishes the conclusions of this research, providing a critical analysis of the EU's policies towards Afghanistan, offering evidence-based recommendations to address these failures and providing valuable lessons for future EU state-building efforts worldwide. It will show that the EU's state-building exercises were inadequate and deeply flawed, failing to account for the growing insecurity within Afghanistan and changes within US strategy. While the EU did have successes, such as the establishment of a peace deal that held for some time, corruption and working at cross-purposes with the USA's shorter-term commitments hindered these successes.
