### What Are Zoos For?

### Heather Browning and Walter Veit

Are zoos an anachronism in the 21st century when we can watch animals from our couches in close-up in their natural habitat without worrying about cruelty? Should they go the way of other bygone era 'spectacles' and 'attractions' that we now regard as barbaric? There are vocal campaigners and activists who believe so.

Heather Browning and Walter Veit disagree, but they acknowledge there is a case to be answered. In *What are Zoos for?* they test the common justifications for zoos (entertainment, education, research, conservation) against the evidence and suggest what the best zoos of the future should look like to ensure that they are primarily for animals and not just for people.



Since 9/11, there has been a huge ramping up of the state's special powers in the name of security, such as indefinite detention, the assassination of suspected terrorists, the use of extraordinary rendition, torture, and changes to due process. However, these powers are often shadowy, they are rarely rolled back, and they can be counterproductive.

This book focuses on understanding the costs of counterterrorism and asking how they can be reduced; global in scope, it looks not just at Western liberal democracies, but at numerous examples from across the world.

In this book, Sally King interrogates the diagnostic label of premenstrual syndrome (PMS) to expose and challenge sexist assumptions within medical research and practice. She powerfully demonstrates how the concept of the 'hormonal' premenstrual woman is merely the latest iteration of the 'hysterical' female myth. By blaming the healthy reproductive body (first our wombs, now our hormones) for the female-prevalence of emotional distress and physical pain, gender myths appear to have trumped all empirical evidence to the contrary.

The book also provides a primer on menstrual physiology beyond hormones, and a short history of how hormonal metaphors came to dominate medical and popular discourses. The author calls for clinicians, researchers, educators, and activists to help improve women's health without unintentionally reproducing damaging stereotypes.
