## The social context of outsourced domestic cleaning

Lotika Singha, University of York

Outsourcing of domestic work in the UK has been steadily rising since the 1970s, but little research has considered white British women working as independent cleaning service-providers.

This book argues that outsourced domestic cleaning can either be done as mental and manual skilled work or as manual and 'natural' emotional/affective labour, depending on the work conditions. This cross-cultural analysis offers a fresh perspective on domestic work, as well as its relationship with feminism by challenging feminist dogmas and popular myths about housework.
