




Rethinking Work, Ageing and Retirement



Call for proposals

Authored and edited books of around 60,000 to 80,000 words will provide country-level and comparative analyses on these topics. The publishing process begins with the submission of a formal proposal that can be made at any stage in the writing process: before starting the book, with a partial draft or with a full draft manuscript in hand. After an initial assessment by the editorial board, each proposal will be peer-reviewed by a minimum of two academic referees. If the book is commissioned for inclusion in the series, the final manuscript will again be peer-reviewed before it is accepted for publication.
